Township of Pine Code Section 92-15

For each and every violation of the provisions of this chapter, any person or persons, firm, partnership or corporation violating any of the provisions of this chapter shall constitute a summary offense and, upon conviction within the magisterial district which includes the Township of Pine, be sentenced to pay a fine of not less than \$50 nor more than \$300, plus costs of prosecution, and, in default of payment thereof, may be committed to the Allegheny County Jail in conformity with the Pennsylvania Rules of Criminal Procedure for a period not to exceed 10 days. Each and every day that any machine or device is used and operated in violation hereof shall constitute a separate and distinct offense under this chapter and shall be subject to separate and distinct penalties hereunder. The penalties provided herein shall not be the exclusive method of enforcing compliance with the provisions of this chapter but shall be in addition to all other legal and equitable remedies available to the Township of Pine.
